### Legislation on data management

The following legal provisions apply to the processing of data by the Centre for Innovation Ecosystem (hereinafter referred to as the Data Controller):

- Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Regulation (EC) No 95/46/EC (hereinafter referred to as "GDPR").
- Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information
- Act CCIV of 2011 on National Higher Education

## Data processing by the controller

The Data Controller collects the data of the interested parties during the attendance at the various university and city events that match its profile, in order to build a database. On the basis of the contact details provided, the Data Controller will subsequently contact the interested parties to present the programmes organised by the Data Controller. The purpose of the processing is to provide information about the programmes and events organised by the IEC and the possibility of participation. Data processed: name, faculty, department, educational institution, email address, telephone number. Legal basis for processing: article 6(1)(a) GDPR: consent of the data subject.

Duration of processing: until consent is withdrawn. Consent may be withdrawn by sending a message to the email address of the Data Controller at innovacio@unideb.hu, specifying the email address to be deleted.

Persons having access: the Data Controller's staff carrying out the tasks of the Data Controller.

# Rights of data subjects and rules governing the exercise of rights

**Right to information**: Pursuant to Article 15(1) of the GDPR, the data subject may request information about the personal data processed by the Controller .

**Right to obtain a copy**: pursuant to Article 15(3) to (4) of the GDPR, the data subject may request a copy of the personal data processed by the Controller.

**Right to rectification**: On the basis of Article 16 of the GDPR, we will amend or clarify your personal data in accordance with your request.

**Right to restriction**: the data subject may request the restriction of processing in the following cases:

- If you contest the accuracy of the personal data, we will restrict processing until the Controller verifies the accuracy of the personal data;
- If the processing is unlawful and the data subject opposes the erasure of the data and requests instead the restriction of their use;

- the controller no longer needs the personal data but the data subject requests them for the establishment, exercise or defence of legal claims; or
- where the data subject exercises his or her right to object, we restrict processing for the period necessary to assess the lawfulness of his or her request.

**Right to object**: In such a case, the Controller will examine the processing of the data subject on the basis of the legal ground of legitimate interest and, if the request is found justified, we will erase the personal data. Enforcement options

If the data subject considers that the processing of his or her personal data by the Controller does not comply with the legal requirements, he or she may initiate proceedings before the National Authority for Data Protection and Freedom of Information (Postal address: 1363 Budapest, PO Box 9, e-mail address: ugyfelszolgalat@naih.hu) or may take legal action.
